## **EXECUTIVE SUMMARY**

Prior to the 92<sup>nd</sup> General Assembly, the State Board of Election Commissioners voted to propose legislation that would authorize the SBEC to conduct a post-election audit of the general election results. In the 2019 Regular Session, Act 888 of 2019 was adopted which provided the SBEC with the authority it requested. The Act also provided that the SBEC would conduct a pilot program following the 2020 General Election to gain experience in conducting post-election audits, and to utilize this experience to develop a more detailed plan for auditing future elections.

The purpose of this audit is to assess the accuracy of the count produced by the ballot tabulators that are utilized to count the ballots cast by Arkansas voters. Pursuant to the requirements of Act 888, the 2020 pilot program was comprised of post-election audits of five counties. The counties selected included White, Pope, Lincoln, Faulkner, and Madison counties.

Based upon the results of the 2020 Post-Election Audit, the SBEC has determined that the voting equipment used and audited in each of the five selected counties rendered a faithful and accurate count of the ballots which were submitted to the system for counting. Based on these findings, it is the conclusion of the SBEC that the ExpressVote system accurately tabulated the election results for the 2020 General Election in the State of Arkansas.

## **METHODOLOGY**

The purpose of this audit is to assess the efficacy of the vote tabulation equipment in service in the State of Arkansas. This assessment was conducted by selecting certain batches of ballots tabulated by the voting equipment and hand counting the actual ballots which constitute the Voter Verified Paper Audit Trail (VVPAT)<sup>1</sup> for Arkansas's voting equipment. This hand count was then compared to the electronic count, as recorded on the official vote totals that were produced by the tabulator, are signed by the poll workers who produced the respective report, and which serves as the legal election results for those ballots.

Pursuant to the requirements of Act 888 of 2019, the SBEC randomly selected the counties to be audited in its December 2<sup>nd</sup> meeting. As provided in section 5 of the Act, the SBEC selected five counties, including one county from each Congressional District and one county with a population of more than 100,000 people. Once selected, counties were notified by letter and SBEC staff worked with the counties to schedule the audit in each county.

For each audited county, Staff randomly selected between the sealed boxes containing voted ballots. For each box that was selected, the SBEC staff broke ballot box seals and hand counted the paper ballots and looked specifically at the votes cast for presidential electors. The hand counted totals were then compared with the totals on the official results tape for that box of ballots. These findings were then documented on a report which is signed under oath by the auditor. Those signed reports are included in this report.

<sup>1</sup> A VVPAT is a paper record which the voter may inspect prior to the voter's ballot being cast which allows the voter to confirm the selection made by the voter on the voting equipment is faithfully represented on the ballot.

## WHITE COUNTY

**CONCLUSION:** DS 200 Tabulator Functioned Correctly

**ADDITIONAL ISSUES TO REPORT:** None

The audit of the voting equipment in White County was conducted on Friday January 15<sup>th</sup> in the White County Clerk's Office. SBEC staff audited the election results from six tabulators and found that the tabulation devices rendered 100 percent accurate results regarding all votes cast for presidential electors in the 2020 General Election. Thirty-one thousand and six (31,006) White County voters cast ballots in the 2020 General Election.



The audit of the voting equipment in Madison County was conducted on Monday, February 8 in the Madison County Courthouse annex. SBEC staff audited the election results from two tabulators and found that the tabulation devices rendered 100 percent accurate results regarding all ballots processed through the scanner tabulator for presidential electors in the 2020 General Election. Seven thousand, three hundred seventy-nine (7,379) Madison County Voters cast ballots in the 2020 General Election.

(\*See attached SBEC Staff Memo regarding this discrepancy. SBEC Staff determined that the tabulator operated correctly. It properly read and tabulated all ballots processed through the scanner, as designed with a 100 percent accuracy rate. SBEC Staff determined that a voter inadvertently placed their ballot in the mistakenly opened emergency slot on the front of the ballot storage section. In so doing, that ballot fell through the small opening at the front of the emergency slot, falling into the ballot box without being processed through the scanner/tabulator. SBEC Staff determined this discrepancy is not a fault by the scanner/tabulator machine. Staff has determined that County officials have taken appropriate steps to ensure this issue will not be repeated in the future.)

This memo is provided to recount my experience while conducting the Audit of Madison County's General Election 2020. Also attached are several documents provided by Clerk Blocker.

On Monday, February 8<sup>th</sup>, 2021, I arrived at the Madison County Courthouse and annex building in downtown. The County Clerk, Ms. Tamitha Blocker, had prepared the annex building/room for my audit work and made all ballot boxes and results tapes available for my purposes.

I randomly selected two boxes to audit, selecting Kingston and St. Paul. The initial count for Kingston, tabulator serial number 0319352002 was 339 total votes according to the Tabulator Results Tape. The Tabulator Results Tap and the ballots, removed from the sealed box, contained the following votes:

The process of conducting the audit was as follows. I removed the ballot box seal and separated the ballots into stacks of ten per each candidate for the Office of President. The totals for Mr. Biden (71) and other non-major party candidates and under vote (10) were correct. However, when tabulating the totals for Mr. Trump, I counted 442 ballots, but the Tabulator Results Tape only recorded 441 ballots with votes for Mr. Trump. I resorted the ballots for Mr. Trump and re-counted, again having 442 ballots with votes for him. I went through the stacks counting each one yet a third time, and again resulted in 442 ballots for Mr. Trump. I totaled the number of ballots, reaching a total of 523 ballots that were removed from the ballot box. The Tabulator Results Tape, however, only recorded 522 ballots.

To confirm my tabulation of 523 ballots, I contacted the County Clerk, Ms. Blocker, to assist me in recounting yet again. She and I both recounted the ballots, and each reached the same result, 442 ballots for Mr. Trump and a total of 523 ballots removed from the ballot box.

I asked that she pull the polling location sign-in and associated paperwork packet. We reviewed the totals provided and discovered that 523 voters presented and signed-in to vote, but that the number of ballots reported on the Tabulator Results Tape was 522.

There was a handwritten note on the sign-in and totals paperwork that asked whether a voter had mistakenly walked out with his or her ballot. Clerk Blocker stated she assumed this note was written election night because of the discrepancy between 523 and 522, Clerk Blocker suggested we load the media into another tabulator and process the ballots again, using the tabulator to verify our hand counted totals number of ballots.

All the tabulators were located in the same room in which I was conducting the audit count. Clerk Blocker prepared a tabulator that had been used for early voting for use in our audit count efforts.

I personally processed each of the 523 ballots through the tabulator. The tabulator confirmed 523 ballots. The Tabulator processed 518 of the 523 ballots but rejected 5 ballots that were damaged. Thus, the tabulator confirmed that I removed 523 ballots from the St. Paul Ballot box.

We then located the Tabulator used for St. Paul and discovered the emergency slot door was open. Clerk Blocker confirmed that the Tabulator was brought from the Polling Location immediately after the election and transported to where we were examining it. She knew of only one location that had to open the emergency slot during the election, but it was NOT the St. Paul location.

It appears that a ballot placed in the emergency bin, could work its way into the ballot box through the slot cut into the emergency box floor towards the front of the bin. Further, Clerk Blocker and I discovered that a ballot, if properly aligned in the emergency slot, could pass from the emergency slot, even with the slot door closed, into the bottom ballot box.

The following day, Clerk Blocker contacted the poll supervisor and tabulator operator regarding the opened emergency slot door. Both Supervisor and operator confirmed that they did not have to open the emergency slot door during voting. However, the operator remembered

the flap already being open. The operator continued, that they did not think to close the flap, so it remained opened all day.

Clerk Blocker reports that she believes the tabulator was transported and set up with the emergency flap open. She states that checking the flap door was not on their machine prep check-off list prior to the General Election. She provides that because of this incident, they will now “retrofit the emergency bin on each DS200 utilizing a piece of cardboard or other type of material and some electrical tap to close the gap/hole between the emergency bin and the ballot box in order to close the access point and prevent a ballot from dropping down into the ballot box from the emergency bin.” She continues, that they will ensure “that the emergency bin flap is in the closed position” as part of the machine prep check-off list. She states this will be checked by election staff during testing and prepping for transport, and again double checked by the delivery and set-up crew.

Further, she states that “[i]n the event a ballot count comes up short in the future and it is believed that a voter left the vote center with their ballot thinking it was a receipt, the Election Commission will double check the poll workers by hand counting the ballots in the box to be certain that was in fact the case.”

It is my conclusion, based on the audit and subsequent inquiry, that the tabulator’s emergency bin flap was opened at some point prior to deployment to the polling location, and that a voter inadvertently inserted his or her ballot in the open bin flap, unknown to poll workers, and that this ballot fell through the open area separating the emergency bin and the ballot box.

Further, the remedial steps proposed by Clerk Blocker appear appropriate to prevent this from occurring in the future, as well as, if a count identifies a discrepancy, that additional actions, such as a hand count of ballots, will be conducted to resolve the discrepancy.

As a follow-up to the post-election audit conducted by the SBEC on February 8, 2021, I contacted the poll supervisor and the DS200 operator at the St. Paul Vote Center to inquire whether they had to open the emergency flap on the DS200 on Election Day. These were the two poll workers at the St. Paul Vote Center who had custody of the key lanyards for the voting machines and ballot box. They both stated that they did not have to open the emergency flap due to a ballot jam; however, the DS200 operator remembered the flap already being open. They did not think to close the flap, so it remained open all day. The poll supervisor who normally serves at this location decided not to work the General Election due to health issues and the threat from COVID-19, and several of our other seasoned poll workers from this location bowed out as well. So, this vote center had a lot of elderly poll workers and several first-time poll workers working this election. After speaking with Robin Watson, our Election Coordinator, we have concluded that the DS200 inadvertently went to the vote center with the flap open, as checking the flap position was not on our machine prep check-off list prior to the General Election. In light of this incident and the knowledge that it is possible for a ballot to pass through the emergency bin into the ballot box, we will implement the following measures for future elections.

1. We will retrofit the emergency bin on each DS200 utilizing a piece of cardboard or other type of material and some electrical tape to close the gap/hole between the emergency bin and the ballot box in order to close the access point and prevent a ballot from dropping down into the ballot box from the emergency bin.
2. Ensuring that the emergency bin flap is in the closed position has now been added to our machine prep check-off list. This will be checked by the election staff testing and preparing the machines for transport to the polling location, and it will be double checked by the delivery and set-up crew.
3. In the event a ballot count comes up short in the future and it is believed that a voter left the vote center with their ballot thinking it was a receipt, the Election Commission will double check the poll workers by hand counting the ballots in the box to be certain that was in fact the case.

There were 523 voters on the List of Electors at the St Paul Vote Center and there were 523 ballots present in the ballot box, though only 522 ballots passed through the scanner. The procedure for the transport of ballots from the vote center to the Courthouse (tabulation location) is as follows: At least four (4) poll workers are to verify the seal numbers that are placed on the ballot box and witness the ballot box being locked and sealed. The poll workers list those seal numbers on a Password/Seal Number List. The poll workers then sign the Password/Seal Number List certifying the seal numbers used to seal the ballot box, as well as other sealed election materials prior to transport to the Courthouse. The Password/Seal List is sealed inside a zippered case that contains the poll books. The election materials are then transported to the Courthouse by the poll supervisor appointed by the Election Commission to return the election materials to the Courthouse. It is then checked in at the Central Tabulation site in the Courthouse by election staff. The seal numbers that were certified by the poll workers are verified once again by both election staff at the Courthouse and the poll supervisor returning the ballot box. The seal numbers are verified to ensure that the box was not tampered with during transport and a signed receipt is issued to the poll supervisor and a copy of the receipt is kept by the Election

Commission (see attached). We have concluded that the emergency bin flap was open during the time the DS200 was at the vote center and that a ballot was inadvertently placed into the emergency bin by a voter and made its way into the ballot box without being scanned.

The November 3<sup>rd</sup> General Election was only the second election in which Madison County utilized the new voting equipment, and we are still learning the system. The emergency flap design flaw was not something that we were aware of until the post-election audit. Hopefully the new measures that will be implemented will prevent this from happening again. If you need any additional information from me, please let me know.

It will say VOID if someone has tampered with or tried to remove the seal. You do not have to check the seal number, only that there is an intact seal in place.
- Check each ExpressVote ballot marking device to ensure that each machine contains an Orange Security Seal behind the Security Access Door on the left side of the machine. You do not have to check the seal number, only that there is an intact seal in place.

Thank you for your follow up. I agree that all evidence shows a voter placing their ballot in the emergency slot and the ballot worked its way into the ballot box. I agree that a change or modification is needed to completely separate the top slot from the bottom box, and I believe that placing and taping a barrier is an appropriate remedy.

Further, checking to ensure the flap is closed is an appropriate pre-deployment and set up check.

If you would be so kind as to share your machine deployment check-list, I would greatly appreciate it. I did not see it in the attached documents.

Part of doing the audit is to identify choke points or places in which the system could improvement. Complete physical separation from top slot and bottom box is appropriate. Speaking of that, do you have the poll workers check the top slot as part of their poll closing procedures?

Again, thank you for your hospitality and you guys did a great job with the election and all its challenges.
