ARKANSAS POLL WATCHERS BILL OF RIGHTS ACT OF 2023

Requires the State Board of Election Commissioners to --

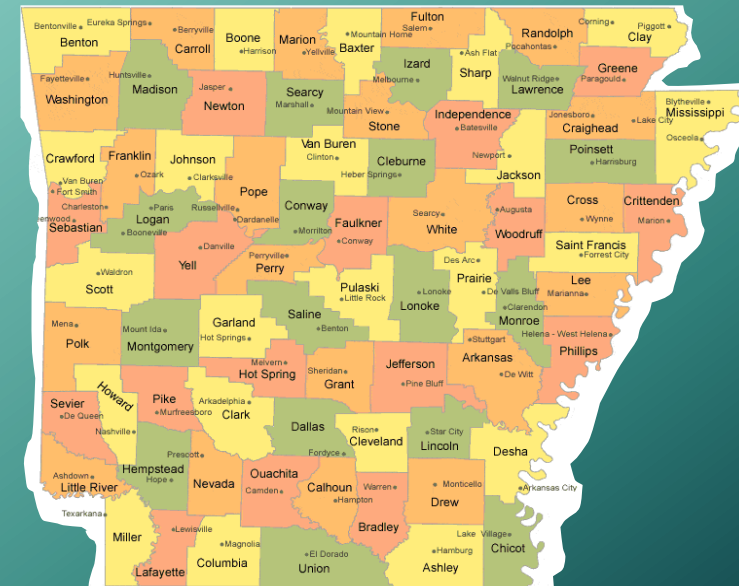
Develop a training program for poll watchers, including on-line training materials concerning the duties, rights, and responsibilities of poll watchers

POLL WATCHER TRAINING AND TESTING

- ▶ You must take a test to be certified as a Poll Watcher
 - Instructions on taking the test will be covered at the end of this slideshow
- ▶ Allow two business days for a "Certificate of Completion" to be emailed to you at the email address you provided in your test

POLL WATCHER QUALIFICATIONS

- (1) Be appointed by candidate, group, or party.
- (2) Be a qualified elector of the state.
- (3) Complete this training course.



POLL WATCHERS ARE

- (1) A representative of a candidate;
- (2) A representative of a group seeking the passage or defeat of a measure on the ballot; and
- (3) A representative of a county or state political party with a candidate on the ballot, or seeking the passage or defeat of a measure on the ballot

QUESTIONS ABOUT RIGHTS AND RESPONSIBILITIES

- The reverse side of the Poll Watcher Authorization Form contains the Rights and Responsibilities of Poll Watchers
- Only 1 poll watcher can be recognized:
 - where voters identify themselves to election officials;
 - within the absentee ballot processing site;
 - at the counting of ballots

POLL WATCHER RIGHTS AND RESPONSIBILITIES

A poll watcher may be:

- (1) A candidate in person, but only during the counting and tabulation of ballots and the processing of absentee ballots;
- (2) An authorized representative of a candidate;
- (3) An authorized representative of a group seeking the passage or defeat of a measure on the ballot; or
- (4) An authorized representative of a party with a candidate on the ballot.

Official recognition of poll watchers:

- (1) Only one (1) authorized poll watcher per candidate, group, or party at any one (1) given time may be officially recognized as a poll watcher at each location within a polling site where voters identify themselves to election officials;
- (2) Only one (1) authorized poll watcher per candidate, group, or party at any one (1) given time may be officially recognized as a poll watcher at each location within the absentee ballot processing site where absentee ballots are processed; and
- (3) Only one (1) authorized poll watcher per candidate or party at any one (1) given time may be officially recognized as a poll watcher at the counting of the ballots.

Poll watcher credentials:

- (1) Except for candidates in person, poll watchers must present a valid affidavit in the form of a "Poll Watcher Authorization Form" to an election official immediately upon entering the polling or counting location.
- (2) Candidates in person attending a counting site or absentee ballot processing site are not required to present a "Poll Watcher Authorization Form" but must present some form of identification to an election official immediately upon entering the site for the purpose of confirming the poll watcher as a candidate on the ballot.

Poll watchers may:

- (1) Observe the election officials;
- (2) Stand close enough to the place where voters check in to vote so as to hear the voter's name;
- (3) Compile lists of persons voting;
- (4) Challenge ballots upon notification to an election official before the voter signs the precinct voter registration list and upon completing a "Challenged Ballot Form" (see Attachment "A");
- (5) Call to the attention of the election sheriff any occurrence believed to be an irregularity or violation of election law. The poll watcher may not discuss the occurrence unless the election sheriff invites the discussion; and
- (6) Be present at the opening, processing, and canvassing of absentee ballots for the purpose of challenging absentee votes in the manner provided by law for personal voting challenges.

Poll watchers representing a candidate or political party may:

- (1) Remain at the polling site after the poll closes if ballots are counted at the poll;
- (2) Be present at the counting of votes by hand or by an electronic vote tabulating device at a central location;
- (3) Be present at the counting of absentee ballots for the purpose of witnessing the counting of ballots by election officials and determining whether ballots are fairly and accurately counted; and
- (4) Upon request made to an election official, inspect any or all ballots at the time the ballots are being counted.

Poll watchers may not:

- (1) Be within six feet (6') of any voting machine or booth used by voters to cast their ballot;
- (2) Speak to any voter or in any way attempt to influence a voter inside the polling site or within one hundred feet (100') of the primary exterior entrance used by voters to the building containing the polling site; or
- (3) Disrupt the orderly conduct of the election.

POLL WATCHER NAME BADGES

- A poll watcher shall wear a **Name Badge** with the Poll Watcher's name only
- Badge cannot contain the name of the Candidate, Group, or Party.



WHERE CAN A POLL WATCHER BE?

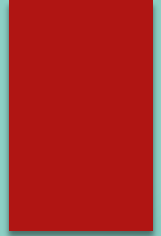
POLL WATCHER OBSERVATION AREAS

- The election officials shall designate areas for poll watchers at each location where ballots are cast in person, including:
 - ▶ (A) Courthouse;
 - ▶ (B) Early voting site;
 - ▶ (C) Vote center; or
 - ▶ (D) Polling location.

POLL WATCHER OBSERVATION AREAS

- A Poll Watcher present in the poll may observe from no closer than three feet and can't be required to stand more than six feet from the:
 - Area where voters are checking in and signing the poll book
 - A Poll Watcher can be farther away than six feet if they choose
 - A Poll Watcher must not be within six feet of a voting machine

A POLL WATCHER SHALL NOT:

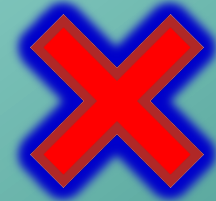


- ▶ (1) Wear campaign material advocating voting for or against a candidate, or for or against a position on a ballot question;
- ▶ (2) Interfere with a voter in the preparation or casting of a ballot; or
- ▶ (3) Hinder or prevent the performance of the duties of any election official.

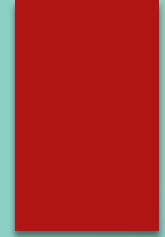
REMINDERS OF POLL WATCHER SHALL NOT's

- ▶ BE WITHIN 6 FEET OF ANY VOTING MACHINES OR VOTING BOOTHS
- ▶ SPEAK TO VOTERS
- ▶ TRY TO INFLUENCE VOTERS:
 - Inside the poll; or
 - Inside the prohibited electioneering zones
- ▶ DISRUPT ELECTIONS

A POLL WATCHER MAY:



- ▶ (1) Bring in voter lists to observe;
- ▶ (2) Speak to a poll worker to initiate a challenge to a ballot; and
- ▶ (3) Speak to a poll judge to execute a challenge to a ballot.
- ▶ (4) Challenge a ballot for review by the County Board of Election Commissioners as a **PROVISIONAL BALLOT**

POLL WATCHER VIOLATIONS

- A poll watcher who violates these laws may be expelled from all polling locations in the county for the duration of the election by the county board of election commissioners, the county clerk, or other designated election officials. *ACA 7-5-312 (h)*
- A person who uses force, intimidation, harassment, or coercion to interfere with a registered voter's ability to vote, an election official's duties, or a poll watcher's duties is guilty upon conviction of a Class A misdemeanor. *ACA 7-5-312 (i)*



HOW TO CHALLENGE A BALLOT:

- ▶ To Challenge a voter's ballot, the Challenge must be made prior to the voter signing the Poll Tablet or Poll Book
- ▶ You must notify the poll worker of your challenge


